Medical/Dental Expenses:

- Letter explaining situation
- Proof of Medical/Dental Expenses
- Copy of Schedule A from 2024 Federal Tax Return

Fluctuating Income:

- Letter explaining situation
- Signed copies of Parents' 2024, 2023 and 2022 Federal Tax Returns
- Copies of Parents' 2024, 2023 and 2022 W2s

Divorce/Separation/Death of Parent:

- Letter explaining situation
- Signed copy of Parents' 2024 Federal Tax Return
- Copy of Parents' 2024 W2s
- Signed statement documenting other sources of income, i.e. Child Support and Alimony
